Branch President's Report

As the Chinese saying purportedly goes '**May you live in interesting times**'. Well, the political events over the past few weeks have certainly been interesting!

DFWA had the opportunity to meet with PM Rudd on 11 Jul 13. President David Jamison has advised that the Labor Government's position has changed but at the time of printing, the changes have not been announced, and it is possible that by the time you read this, the Labor policy will have been made public. This is a watershed moment. **For the first time, we now have both major political parties acknowledging, through their revised policies, that CPI alone cannot maintain purchasing power and that a better indexation system for military super is required.** But does this mean a "fair go" for all current and former ADF members with access to military super? Does it mean that DFWA and ADSO can pack up their bat and ball and go home? The answer to both questions is an emphatic NO! Whilst the Coalition policy has been announced there is speculation that Labor will offer something similar. If that is the case, the policies of both political parties still fall well short of a fair go for **ALL**. You can rest assured that the Fair Go! Campaign will continue and DFWA and ADSO will not relent in their endeavours to achieve a fair and equitable outcome. The situation remains fluid and if you want to be kept up to date, please ensure we have your current email address.

Continuing with the military super theme, the executive of the Fair Go campaign, including our National DFWA President, met with the LNP shadow ministers responsible for Defence, Veterans Affairs and Superannuation (Ronaldson, Robert, Johnstone and Cormann). The concept was to get into their heads before the bureaucrats did on the critical issues facing the Fair Go! A major discussion topic was the shortcomings of the MSBS scheme, and they were interested in hearing our views on what was needed to 'fix' MSBS. Issues identified included Maximum Benefit Limits (MBLs), indexation of pensions and preserved benefits, access to the employer benefit when one leaves the ADF, and indexation of the spouses preserved benefit in family law cases. Currently there are about 55000 contributors, 9000 receiving a pension and 87000 with preserved benefits in the MSBS scheme.

Why We Bother...

Bob and Wendy (not their real names) had their future carefully mapped out. After a tough 28 years of Army life involving forced separations from his family during overseas deployments and frequent postings around Australia, Bob had just one year to go until his compulsory retirement age. They sought financial advice and knew that Bob's military superannuation would allow them to pay off the house mortgage and his residual retirement pay would be enough to live in modest comfort. He hoped to gain some part time work to supplement his superannuation, but at age 55, he was realistic about his prospects.

Then, all their plans fell apart with an early morning knock on the door. Bob had collapsed and died from a massive heart attack whilst on his morning jog before work.

Bob had reassured Wendy that if anything ever happened to him, she would be looked after financially because compulsory super contributions had been deducted from his salary over the past 28 years, and the scheme had a death benefit that provided a widow's pension to guarantee her needs would be met.

An important part of that guarantee was that the Government would ensure regular cost of living adjustments were made to Wendy's pension to protect her **real purchasing power** over future years.

But what Bob and Wendy didn't know is that successive Governments had quietly fiddled with the cost of living adjustments over the past 20 years so that retirement pay no longer maintained real purchasing power.

In Wendy's case, she is now losing \$348 per fortnight compared with what she should be receiving had her widow's pension been adjusted the way Parliament intended back in 1976 when automatic indexation was first legislated.

That's \$348 per fortnight being ripped from Wendy's pocket by the Government because the Parliament now refuses to honour its obligations to retired and invalid servicemen and women and their widows. **Wendy's income level has now fallen into the social welfare safety net and she has been forced to apply for financial support from Centrelink. But here's the rub. Wendy is in her mid 50s and does not qualify for age pension relief.**

Wendy's financial loss is typical of the disgraceful situation faced by many retired, invalid and widowed members of the ADF family. The value of their pensions will continue to slide further into the social welfare trap unless this insidious and unfair policy can be overturned.

But in Parliament, Minister Snowdon chose to recite the example of super benefits for a mythical Colonel retiring tomorrow as representative of the retired military family. And on 15 May 2013, the same Minister said he was ***"surprised at the dishonest way in which this debate has been repeated around the country by some elements of the returned services community"***.

I will leave it to you to judge the integrity of the two sides to this debate.

It is the *Wendy's* in the ADF family that DFWA and ADSO are fighting this battle for. It's *why we bother*.

But we cannot do it without your help. As we head towards the election, please support the **Fair Go Campaign** in whatever way you can.

DVA will treat the following conditions, although they may not accept them as being Service caused:


- All types of cancers
- All types of nervous conditions
- TB, if you are unlucky enough to suffer from it.

The Statement of Principles (SOP) on prostate Cancer has been amended by the Repatriation Medical Authority by adding "smoking" as a cause to prostate cancer.

The Administrative Appeals Tribunal has decided in favour of a War Widow whose husband died of a heart condition. The AAT determined that the condition was causally related to his service in New Guinea during WW2.

DFWA QLD Shows its Appreciation

DFWA QLD President Rob Shortridge presented a certificate of appreciation to Marketing Manager Sarah Rackemann from Property Solutions for their generous support in hosting the Gold Coin Donation Gift Wrapping Service at the Barracks Shopping Centre last Christmas.

The National Disability Insurance Scheme (NDIS)

The Government has announced the introduction of a National Disability Insurance Scheme. The details of the scheme are currently being considered by Parliament and media reporting has revealed that the proposed arrangements will exclude people aged 65 and older.

DFWA has concerns about how the NDIS legislation may affect veterans DVA benefits, including the impact of any age limitation for the new scheme. These concerns have initially been raised at a DVA operational working group meeting which prompted the following response from the Chair, Major General Chalmers, to members at the meeting:

The Chair reassured members that he considered the NDIS will not adversely affect veterans. DVA clients will still be covered by their card entitlements and if NDIS covers additional assistance then it is most likely DVA will also offer those services.

In relation to the 65+ age exclusion, the general consensus at the meeting was that NDIS policy and procedures are still in the 'Work In Progress' stage and details on who will be affected and how some of the procedures and entitlements will be implemented are still not known.

There is a keen awareness of the potential problems associated with the NDIS and DFWA will continue to closely monitor developments as the scheme is rolled out for the trial stages.

Hello...Hello.... Are you out there???

Do you want to hear from us through email? DFWA regularly sends out updates to our members to keep them informed on important developments. This is the only way we can keep in touch with you between each issue of Camaraderie/Hotline.

But to receive these updates, you have to tell us your email address and most importantly, tell us when you change your email address. Please take a minute to check that the email address you are using is the same as the email address you have given DFWA.

FREQUENTLY ASKED QUESTIONS

Am I up to date with my membership?

Most members don't think about this until they receive their latest Camaraderie/Hotline. Here is the hint above your name and address on the mail out cover sheet there will be printed either the word **Life** or a year e.g. **2010**. If this number does not reflect the current year and there is a membership form on the back of your mail out slip it is likely you are in arrears.

Sometime members forget to tell us that they have moved or changed their phone numbers (land line and mobile). Maybe you just change your email address? Or your internet service providers, there are all sorts of reasons. Remember when you change over all your utilities, think of us too.

At the moment we are receiving quite a few "Mail Delivery Failures", sometimes the mailbox is full, we cannot do anything about that. However, the "User Unknown" we can correct if we receive the right information.

What happens when a member passes away?

Unless we are notified, we really don't know. All of our committee members are volunteers; they don't read the obituaries anymore just in case it tells them not to get up that morning.

What we do request is for family members of the deceased to please show a little bit of kindness to the gentlemen who have been working to get a fair deal for your loved one.

If the deceased had a life membership this membership will automatically be transferred to the members *surviving widow*. There may be some teething problems when we are first notified, the computer database may spit out the wrong information and the Camaraderie/Hotline might be addressed to the deceased.
